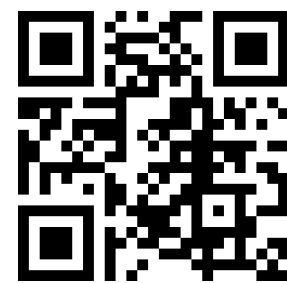

Performing important tasks of the works council

- Monitoring the employer in the implementation of laws
- Advocating for the compatibility of family and work
- Making an active contribution to the integration of people with (severe) disabilities
- Exercising participation rights in the interests of the company and workforce
- Negotiating and concluding important works agreements

Introduction to the participation rights of the works council

- Principle of trusting cooperation - what does this mean in concrete terms?
- What does a successful monthly meeting look like?
- Information and suggestion rights, e.g. in personnel planning
- Information and consultation rights, e.g. when planning new work processes
- Participation rights in personnel matters, e.g. recruitment and dismissals
- Co-determination rights, e.g. for working time regulations and other social matters
